MAKE PLANS NOW TO ATTEND THE ANNUAL MEMBERS' MEETING — FEBRUARY 11

An important item of business (other than refreshments and door prizes, of course) will be the election of new Board members. The Nominating Committee has nominated the following individuals.

Nominated for Three-Year Terms:

- **Damon Boggs** – Damon is a Network Support Analyst and has served as a Credit Union volunteer for 17 years. He is currently Vice Chairman of the Board and serves on the Security Committee, Executive Committee and Web/Technology Committee.
- **Renée Butler** – Renée is Unit Manager of Oklahoma Contract Administration. She has been an active volunteer with the Credit Union since 1990 and has held the office of Secretary to the Board of Directors since 1993. She also currently serves on the Executive and Communications Committees.
- **Leigh Ann Hancock** – Leigh Ann has worked at BCBSOK for over 23 years. She has served on the Communications Committee as well as the Supervisory Committee. Leigh Ann is the Manager of Reporting and Analysis for the Medicare Part D program. She has a bachelors degree from the University of Tulsa.

Nominated for One-Year Terms:

- **Kevin Holmes** – Kevin has worked at BCBSOK for over 20 years. His current position is in Budgets and Systems Support as the Budget Analyst for the Oklahoma, OK Property & Casualty and EISM divisions. He currently serves on the Supervisory Committee and has a bachelor's degree in accounting from the University of Tulsa.
